DIVISIONS: Junior – Ages 15 & under: Monday, May 31, 2010 at 2 PM
Adult – Ages 16 & over: Monday, May 31, 2010 at 4 PM

- ❖ Contest will be held at the Sumpter Country Festival grounds, 23501 Sumpter Road, Belleville MI in the pavilion.
- ❖ Registration and \$20 entry fee required. Checks/Money Orders payable to: **Party Time Entertainment**
- ❖ Registrations will be accepted until contest is determined full. Registrations accepted on site at the festival beginning 30 minutes prior to the start of each division or by postal mail.
- ❖ Prize packages will be awarded to 1st, 2nd & 3rd place winners in each division. Prizes to include trophies and professional studio recording session at Talent Live Studios, Canton MI. Additional prizes may be added. Points from entry / placement in this contest will be awarded toward qualification for “Michigan Grand Championship”.
- ❖ Talent Search 2010 is a Party Time Entertainment production. Questions regarding the contest, rules, registration, performance material etc. should be directed to Party Time Entertainment: (734) 620-0246 or email: info@partytimemusic.net
- ❖ All types of **family friendly** acts are welcome to compete – singers, dancers, instrumentalists, etc. Every attempt will be made to accommodate performers with staging, however, some limitations do apply. Bands, please call prior to contest date.
- ❖ FOR GROUP REGISTRATIONS – All members performing in the group must be within the age limits for that division. Mixed age groups should call prior to contest date for a determination of eligibility. Age is determined as of May 31, 2010. Proof of age may be required – please be prepared to validate age if requested.
- ❖ Contestants are required to supply their own background music. All prerecorded background music should be on a commercially available CD. For singers, background tracks must **NOT have any lead vocals**. Please be advised that some “homemade” CDs may not play on our equipment. Turn in music marked with your name and track number at check in. CDs will be available for return shortly after the conclusion of each division.
- ❖ Contestants may also choose to sing without music or with instrumentation.
- ❖ Check in will begin 30 minutes prior to the start of each division. A random draw of numbers at check in will determine the performance order of show.
- ❖ Sound system and microphones will be supplied by the Talent Search contest. Contestants are allowed to use their own microphones only if they are compatible with our sound system. This determination will be made by our sound technician. Please make a note of your equipment on the registration form.
- ❖ A qualified panel of judges will score the contest. Winners will be determined by a total point score in various performance categories. Winners will be announced at the conclusion of each division. Sample score sheets are available.
- ❖ All decisions made by the Talent Search show director, Talent Search judges, Party Time Entertainment LLC, Sumpter Township / Sumpter Country Festival and its Board of Directors are final.
- ❖ Performers / parents agree to release any photos, video and / or audio recordings of their performance in Talent Search 2010 for use as determined by Party Time Entertainment and / or the Sumpter Country Festival / Sumpter Township.
- ❖ All performers agree to maintain the family atmosphere of the fair in their choice of performance material, costumes, choreography, etc. **Please select age appropriate material.** Violations may result in disqualification without refund of registration fee.
