## CALHOUN IDOL 2010 - REGISTRATION REQUIREMENTS / CONTEST RULES

\* Registration and \$20 registration fee are required. Checks / money orders should be made payable to:  
**Calhoun County Fair**

\* Registration forms will be available & accepted at the fair office. Registration forms also available online: [www.calhouncountyfair.org](http://www.calhouncountyfair.org) Registrations postmarked / received by August 10, 2010 will receive 2 gate passes per registered performer. Registrations will also be accepted at the stage prior to each division. Registrations after August 10, 2010 will not receive gate passes.

\* The "Calhoun Idol" competition will be held during the Calhoun County Fair, Marshall, Michigan on Saturday, August 21, 2010. 2 divisions of competition for solo singers: Juniors (ages 15 & under) and Adults (ages 16 & over). Proof of age required. Please be prepared to validate age if requested.

\* Residency in Calhoun County is not required to participate in "Calhoun Idol"

\* "Calhoun Idol" is a Party Time Entertainment production. **Prizes to be awarded:** A prize package will be awarded to 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> place winners in each division. Prize package to include: 1<sup>st</sup> Place: \$100 Savings bond, 2-hour studio recording session at Talent Live Studios, Canton MI & trophy; 2<sup>nd</sup> Place: \$75 Savings bond, 1-hour studio session & trophy; 3<sup>rd</sup> place: \$50 savings bond, 1-hour studio session & trophy. Additional prizes may be added.

\* **NEW POINT SYSTEM THIS YEAR!** Contestants will earn points just for entering a Party Time Entertainment contest. Additional points will be awarded based on contest performance (place finish). Earned points will be accumulated by contestants throughout the contest season. Top point earners will qualify for Michigan Grand Championship event and will be eligible to compete for additional prizes.

\* Contestants are required to check in at the stage 30 minutes prior to the start of each division. Junior Division check in will begin at 3:30 PM; contest start at 4 PM. The Adult Division check in will begin at 5:30 PM; contest start at 6 PM. Performance order will be determined by a random draw of numbers at check in. Please turn in your background music marked with your name and track number at check in. Contestant's CDs will be available shortly after the conclusion of the contest. Please remember to pick up your CDs from the sound technician!

\* Each contestant will sing one song, 4 minutes or less in length. Combinations of songs are allowable provided the contestant stays within the 4 minute time limit. Contestants must perform solo.

\* Contestants are required to supply their own background music on standard commercially available "karaoke type" CD – NO lead vocals. "Homemade" CDs are acceptable to use, but may not play properly on some equipment. Sound system and standard microphone will be provided. Contestants will be allowed to use their own microphone if equipment is compatible with our sound system; sound technician to make determination.

\* Contestants may choose to accompany themselves (for example, guitar or keyboard) instead of using prerecorded background tracks. Contestants must supply instrument and any necessary accessories. Contestants may also choose to sing a cappella (without music).

\* A qualified judging panel selected by the Calhoun County Fair and / or Party Time Entertainment will score the contest. The winners will be determined by total point score from various vocal categories. In case of a tie score affecting 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> place, the contestants that are tied will be asked to sing again. Contestants may choose to sing the same song or a different song. The contestants will be scored again to determine the final winner. Sample score sheets are available.

\* Contestants agree to maintain the family atmosphere of the fair in their choice of performance material, costumes, choreography, etc. Violations may result in disqualification without refund of registration fee.

\* Contestants / parents agree to release any photos, video and/or audio recordings of their performance for use as determined by the Calhoun County Fair and / or Party Time Entertainment

\* All decisions made by Party Time Entertainment, Calhoun County Fair and its Board of Directors, and Calhoun Idol judges are final.
